You will be taxed social security and medicare taxes if you do not meet the criteria for the student FICA exemption based on the pay period. This includes summer criteria and is determined by the IRS by pay period. Please also note that biweekly payroll pays for time worked 2 weeks in arrears.

A student must work less than 30 hours per week and be enrolled at least $\frac{1}{2}$ time – 6 hours for undergraduate students and 3 hours for graduate students during the fall and spring semesters and 3 hours for undergraduates and 1 hour for graduates during the summer semester. If you do not meet **BOTH** of these criteria in an **individual pay period**, Social Security and Medicare taxes will be withheld from your paycheck.
